#### **PUBLIC HEARING 2023 BUDGET**

Mr. Roberts opened the public hearing. The Trustee read the proposed levies and budgets. The Trustee also explained that the General Fund is significantly higher, and the Fire Department Fund is significantly lower than in the past because the Indiana State Board of Accounts will require all LIT revenues to be receipted to and spent from the General Fund. This will shift all fire department benefits from the Fire Fund to the General Fund in 2023.

After a brief discussion, Mr. Roberts closed the public hearing. The budget adoption is set for September 6<sup>th</sup> at 10:00 a.m.

### **NEW BUSINESS**

Part-Time Pay Scale

To stay competitive, the Trustee requested pay increases for all part-time employees. Mr. Roberts recommend amending the salary resolution to include "not to exceed" amounts. The Trustee will confirm the amounts to stay equal with Cicero FD. Mr. Hill moved to approve this effective immediately. Mr. Roberts seconded, and the motion carried unanimously.
