## ACCOUNTING AND ASSISTANCE SOFTWARE CHANGE

Mrs. Cook informed the board that she would like to purchase new software from TomsWeb. The cost of the software is \$4905. She advised that there was not enough money appropriated for such purposes in the 2019 budget and that it may have to come from the Rainy Day Fund. This prompted some discussion regarding the balance of the Rainy Day Fund, which the Trustee was trying to locate- in addition to the approved budget. The Trustee has the budget amounts that were entered into Gateway but cannot locate the actual budget signed by the Board. Mr. Cook stated that he knows the Township has the money and the board agreed to the purchase.

## ANNUAL REPORT

The Trustee informed the Board that the annual report was not yet complete and that she will invite

the previous Trustee to the next meeting in order for her to have the opportunity to answers questions should they arise.
