FIRE CHIEF'S REPORT

Updated S.O.G. The updated Standard Operating Guidelines were presented to the Board for their review.

Fire Department Building. Chief Muszar reported that the rusted out beam in the back bay of the station had been repaired with costs expected to come in from \$3000-\$5000. This was good news to all as the original estimate was around \$18,000.

TRUSTEE REPORT

Assistance and Events Update. Mrs. Duncan updated the Board regarding recent COVID-19 related grants the Township has received:

Grant 1 from OCRA in the amount of \$19,549 which may be used for food and hygiene items for residents in the incorporated portion of Cicero.

Grant 2 from the CDBG in the amount of \$37,600 which may be used for the unincorporated portion of Jackson Township for rent, utilities, and burial assistance.

Grant 3 from HCCF, awaiting further guidance.

The Energy Assistance Program has been extended to July 31 and a shorter township assistance application has been approved for use during the crisis.

All information has been turned in for the new township website.




