WAIVER AND LIABILITY RELEASE

This Waiver and Liability Release (the "Waiver") is executed on this ___ day of _____, 2023 by _____ ("Releasor"). Releasor has voluntarily agreed to display artwork at the Jackson Township ("Township") Bicentennial event in April 2023.

Releasor hereby waives, releases and absolves the Township, its elected officials, officers, and employees of any and from any and all claims, losses, liabilities, or damage of any kind arising from or related to any injury or damage, which could be sustained or caused to Releasor's artwork during the time it is in the custody of the Township. The Township will take all reasonable precautions to ensure the artwork is protected. But, it cannot anticipate and prevent all accidents that could occur and cause damage to the artwork. Releasor hereby confirms he/she is willing to assume the risk. This Release shall be irrevocable, binding and enforceable against Releasor and his/her successors, assignees, heirs, officials, and legal representatives. This Release inures to the benefit of the Township and all of its officers and employees, directors, agents, insurers, attorneys, successors, and affiliates.

Releasor understands that by signing this Release, he/she is waiving, releasing, and discharging any and all claims, demands and legal actions that he/she may have against the Township, presently or in the future, related in any way to the donated artwork, to the maximum extent permitted by law.

This Release shall be construed in accordance with the laws of the State of Indiana. Releasor agrees that any mediation, suit, or other proceeding relating to this Release and any activities covered hereby must be filed or entered into only in Indiana and the federal or state courts of Indiana. In the event any clause or provision of this Release is deemed invalid, the invalidity of such clause or provision shall have no effect on the remaining provisions, which shall continue to be enforceable.
